Introduction and Background

Summerswood Primary School recognises that positive behaviour and good attendance are essential in order for pupils to get the most of their school experience, including their attainment, wellbeing and wider life chances.

The law entitles every child of compulsory school age to an efficient, full-time education suitable to their age, aptitude, and any special educational need they may have. It is the legal responsibility of every parent to make sure their child receives that education either by attendance at a school or by education otherwise than at a school. Your child is of compulsory school age at the start of the term after they turn 5 years old.

Where parents decide to have their child registered at school, they have an additional legal duty to ensure their child attends that school regularly, on time. This means their child must attend every day that the school is open, except in a small number of allowable circumstances such as being too ill to attend or being given permission for an absence in advance from the school.

The Department for Education (DfE) has produced statutory guidance for maintained schools, academies, independent schools, and local authorities. It is called "[Working together to improve school attendance](#)" and it includes a National Framework in relation to absence and the use of legal sanctions. Our School Attendance Policy reflects the requirements and principles of that guidance.

This policy is written with the above guidance in mind and underpins our school ethos to:

- promote children's welfare and safeguarding.
- ensure every pupil has access to the full-time education to which they are entitled.
- ensure that pupils succeed whilst at school.
- ensure that pupils have access to the widest possible range of opportunities at school, and when they leave school.
- Offer a "support first approach" in which we speak to families and support pupils with any issues that may be contributing to poor attendance

It has been developed in consultation with school governors, teachers, local Headteacher Associations, the Local Authority and parents and carers. It seeks to ensure that all parties involved in the practicalities of school attendance are aware and informed of attendance matters in school and to outline the school's commitment to attendance being everyone's responsibility. It details the responsibilities of individuals and groups involved and the procedures in place to promote and monitor pupil attendance.

In addition, all schools follow the DfE's statutory safeguarding guidance, Keeping Children Safe in Education, which emphasises the importance of understanding the potential vulnerabilities of children who are missing or absent from education.

Our policy aims to raise and maintain levels of attendance by:

- Promoting a positive and welcoming atmosphere in which pupils feel safe, secure, and valued.
- Raising and maintaining a whole school awareness of the importance of good attendance and punctuality.
- Ensuring that attendance is monitored effectively and reasons for absences are recorded promptly and consistently.
- Speaking to families and listening to any question or concerns that they may have about attendance. Supporting pupils through any issues that may be contributing to poor attendance

For our children to gain the greatest benefit from their education it is vital that they attend regularly and be at school, on time, every day the school is open unless the reason for the absence is unavoidable. **Pupils must attend every day, unless there are exceptional circumstances, and it is the Head Teacher not the parent, who can authorise the absence.**

Promoting Regular Attendance

At Summerswood Primary school, we believe in developing good patterns of attendance and set high expectations for the attendance and punctuality for all our pupils from the outset. It is a central part of our school's vision, values, ethos and day to day life. We recognise the strong connections between attendance, attainment, safeguarding and wellbeing.

Helping to create a pattern of regular attendance is the responsibility of parents, pupils and all members of school staff.

To help us all to focus on this, we will:

- Submit a daily attendance return to the Department of Education, in line with the legal expectations placed on all schools.
- Build strong relationships and work jointly with families.
- Give parents/carers details on attendance in our weekly newsletters.
- Promote the benefits of high attendance.
- Accurately complete admission and attendance registers and have effective day to day processes in place to follow-up absence as required by law.
- Celebrate excellent attendance by displaying and reporting individual and class achievements, around the school, and in our weekly newsletter.
- Reward good or improving attendance
- Report to parents/carers regularly on their child's attendance and the impact on their progress.
- Contact parents/carers should their child's attendance fall below the school's target for attendance.
- Invite parents and carers in to school to meet with the attendance champion, a member of SLT/ or their child's teacher to discuss ways in which we can work together to improve a child's attendance.

Understanding Types of Absence

Any absence affects the routine of a child's schooling and regular absence will seriously affect their learning journey and ability to progress. Any pupil's absence or late arrival disrupts teaching routines and so may affect the learning of others in the same class. Ensuring a child's regular attendance at school is a parental responsibility and allowing absence from school, without a good reason, creates an offence in law and may result in prosecution.

Every half-day absence from school has to be classified by the school (not by the parent), as either **authorised** or **unauthorised**. This is why information about the cause of any absence is always required. Each half-day is known as a 'session'.

Authorised absences are morning or afternoon sessions away from school for a genuine reason including:

- Illness such as vomiting or diarrhoea
- A fever of 38°C or above
- An **unavoidable** medical appointment - although we do ask that you organise these outside of school hours where possible and will always ask for evidence before we can mark an absence as authorised for a medical appointment- *Please note that we can only authorise absence when the appointment is for the pupil- not a family member*
- An infectious illness such as chicken pox, where the NHS guidance states that a child must remain off of school for a certain amount of time- please see the links in Annex C for guidance on when your child may be too ill to attend school
- A family bereavement
- Please note that you may be asked to provide evidence of your child's illness before this is marked as authorised

Unauthorised absences are those which the school does not consider reasonable and for which no 'leave' has been granted. This type of absence can lead to the school referring to the Local Authority for penalty notices and/or legal proceedings.

Unauthorised absence includes, but is not limited to:

- parents/carers keeping children off school unnecessarily e.g., because they had a late night or for non-infectious illness or injury, such as a cough or cold (with no temperature over 38°C) that would not affect their ability to learn.
- absences which have never been properly explained.
- shopping trips.
- looking after other children or children accompanying siblings or parents to medical appointments.
- their own or family birthdays.

- holidays taken during term time, not deemed 'for exceptional purposes' by the headteacher, including any arranged by other family members or friends.
- day trips.
- other leave of absence in term time which has not been agreed.
- children who arrive at school after the close of registration are marked using a 'U'. This indicates that they are in school for safeguarding purposes, however, is counted as unauthorised absence for the session.

Persistent Absenteeism (PA) and Severe Absenteeism (SA)

A pupil is defined by the Government as a '**persistent absentee**' when they miss 10% or more schooling across the school year for any reason; this can be *authorised* or *unauthorised* absence. Absence at this level will cause considerable damage to any pupil's education and we need the full support and co-operation of parents to resolve this. All pupils who have attendance levels of 90% or below are considered to be a persistent absentee.

A pupil who has missed 50% or more schooling is defined by the Government as '**severely absent**'. Pupils within this cohort may find it more difficult to be in school or face bigger barriers to their regular attendance and, as such, are likely to need more intensive support.

Absence Procedures

We monitor and review all pupils' absence, and the reasons that are given, thoroughly.

If a child is absent from school the parent must follow these procedures:

- Contact the school on the first day of absence **before 9.15 am**
- The school has a voicemail available to leave a message, or you may call into school personally and speak to the office staff. Please be aware that, if you leave a voicemail to report your child's absence, **the message should be as detailed as possible. Please include your child's name, class, a list of all symptoms (including the temperature recorded if they have one).**

- **Please note that** you may receive a call from the school so that we may discuss the absence before making a decision as to whether the absence is to be recorded as authorised.
- Contact the school on every further day of absence, again before **9.15am**
- Ensure that your child returns to school as soon as possible and you provide any medical evidence, if requested, to support the absence. Medical evidence may be requested where your child is having multiple periods of absence which are reported as being due to medical reasons. When determining whether a child is too ill to attend school, both parents and school staff can consider the advice contained within the NHS Guidance on School Absence and Childhood Illness see Annex C.
- If we believe, in line with NHS guidance that your child's illness is mild enough for them to be able to attend school, then we will advise you of this and would then expect your child to attend school
- We ask that any routine medical appointments are made outside of school time where possible. If your child has to have an appointment within the school day, please send confirmation of the appointment to attendance@summerswood.herts.nhs.uk

Please note that we are unable to authorise absence for a medical appointment unless evidence of the appointment is provided.

If your child is absent, we will:

- Telephone or text you on the first, and every subsequent day of absence, if we have not heard from you. **However, it is your responsibility to contact us.**
- If we are unable to make contact with parents by telephone, we will telephone emergency contact numbers, make a visit to the family home as well as sending letters all in the interests of safeguarding. Please inform us asap of any changes to phone numbers or address.
- The Local Authority will be informed if no contact has been made with parent/carers by the 10th day of absence (or sooner if deemed appropriate) as The School Attendance (Pupil Registration) (England) Regulations 2024 Section 13 requires schools to inform the local authority of any pupils absent from school and where absences amount to more than 10 or more **days**, either consecutively or irregularly and have been unauthorised. This means school will have unauthorised 20 am/pm sessions of absences. Schools are also under a safeguarding duty, under **section 175 of the Education Act 2002** to investigate any

unexplained/unauthorised absences. At this point your child will be considered to be “absent from education”.

If absence continues, we will:

- Write to you, call you or speak to you in person if your child’s attendance is below 95% and/or where punctuality is a concern.
- Arrange a meeting so that you may discuss the situation with the Attendance Champion, your child’s class Teacher or a member of the Senior Leadership Team
- Consider and offer reasonable adjustments.
- Offer a Families First Assessment to ensure appropriate support is considered.
- Create a personalised robust support plan, an attendance plan, to address any barriers to attendance and make clear each person’s role in improving the attendance patterns of your child.
- Offer signposting support to other agencies or services, if appropriate.
- Seek advice, guidance and support from the Local Authority Statutory Attendance Support Team and consider appropriate legal sanctions, such as Fixed Penalty Notices if attendance deteriorates following the above actions.
- For unexplained absence we will follow safeguarding procedures whereby we may make welfare visits to your home address, contact children’s services and/or the police to conduct safety checks.
- **Please remember that if you have enrolled your child at Summerswood Primary school, then you have a legal duty to inform us promptly and accurately of the reasons for absence. If you are experiencing issues relating to attendance and/or punctuality, please do let us know as soon as possible so that we can explore all possible methods of support.**

Lateness

Poor punctuality is not acceptable and can lead to irregular school attendance patterns. Good timekeeping is a vital life skill which will help children as they progress through their school life and out into the wider world.

Pupils who arrive late disrupt lessons and, if a child misses the start of the day, they can feel unsettled and embarrassed and risk missing vital work and important messages from their class teacher.

The times of the start and close of the school day for all pupils at Summerswood Primary School are:

Gates open: **8.40am**

Registration starts: **8.50am**

Registration closes: **9am**

End of the school day: **3.15pm (3pm for nursery and 3.05pm for Reception)**

How we manage lateness:

- The school day starts at **8.40am** when children can begin to come into school;
- Registers are taken at **8.50am**;
- Children arriving after **8.50am** are required to come into school via the school office. They must sign in via our InVentry system and include the reason for being late.
- In accordance with the Regulations, if your child arrives after 9.20am time, they will receive a mark that shows them to be on site – ‘U’, but this will **not** count as a present mark and it will mean that they have an unauthorised absence; Please note that U marks can be counted toward the threshold for Fixed Penalty Notices for any unauthorised absence.
- The school may contact parents/carers regarding punctuality concerns;
- From time to time a member of school staff will undertake a ‘Late Gate’ check, greeting late arrivals at the main entrance to the school.

If your child has a persistent lateness record, you may be asked to meet with The Attendance Champion, but you can approach us at any time if you are having difficulties getting your child to school on time. We expect parents and staff to encourage good punctuality by being good role models to our children and, as a school, we celebrate good and improved class and individual punctuality. Unauthorised lateness could result in the school seeking advice and guidance from the Local Authority.

Understanding barriers to attendance

Whilst any child may occasionally have time off school because they are too unwell to attend, sometimes they can be reluctant to attend school. Any barriers preventing regular attendance are best resolved between the school, the parents, and the child. If a parent thinks their child is reluctant to attend school, then we will work with that family to understand the root problem and provide any necessary support. We can consider a Families First Assessment, use outside agencies to help with this, such as the School Nurse, Mental Health and Emotional Wellbeing support services, a Family Support Worker, or the relevant Local Authority team/s. Where outside agencies are supporting the family, you may be invited to attend a Team Around the Family meeting (TAF) to consider what is working well and what needs to improve. An individual support plan will be agreed and subsequently reviewed.

Some pupils face greater barriers to attendance than their peers. These can include pupils who suffer from long-term medical conditions or who have special educational needs and disabilities, or other vulnerabilities. High expectations of attendance remain in place for these pupils; however, we will work with families and pupils to support improved attendance whilst being mindful of the additional barriers faced. We can discuss reasonable adjustments and additional support from external partners, where appropriate.

Under the DfE's statutory guidance, schools are required to submit a sickness return to the Local Authority for all pupils who have missed/are likely to miss 15 or more school days (consecutive or cumulative) due to medical reasons/illness.

Local Authority Attendance Support Team

Local Authority Attendance Support Specialists work strategically by offering support to schools, to reduce persistent absence and improve overall attendance.

Parents/Carers are expected to work with the school and local authority to address any attendance concerns. Parent/Carers should proactively engage with the support offered, aiming

to resolve any problems together. This is nearly always successful. If difficulties cannot be resolved in this way, the school may consider more formal support and/or refer the child to the Local Authority. If attendance does not improve, legal action may be taken which may be in the form of a Penalty Notice (see Annex B for the Hertfordshire Code of Conduct) or other legal options available to the Local Authority such as prosecution in the Magistrates Court.

School Attendance and the Law

New legislation was passed, The School Attendance (Pupil Registration) (England) Regulations 2024 which introduced a National Framework in England. By law all children of compulsory school age must receive an appropriate full-time education (Education Act 1996). Parent/Carers have a legal duty to ensure their child attends school regularly at the school at which they are registered.

Parent/Carers may be recognised differently under education law, than under family law. Section 576 of the Education Act 1996 states that a 'parent', in relation to a child or young person, includes any person who is not a parent (from which can be inferred 'biological parent') but who has parental responsibility, or who has care of the child.

A person typically has care of a child or young person if they are the person with whom the child lives, either full or part time and who looks after the child, irrespective of what their biological or legal relationship is with the child.

National Framework for Penalty Notices

There is now a single consistent national threshold for when a penalty notice must be considered by all schools in England, of 10 sessions (usually equivalent to 5 school days) of unauthorised absence within a rolling 10 school week period. The 10 sessions of absence do not have to be consecutive and can be made up of a combination of any type of unauthorised absence (G, O and/or U coded within the school's registers). The 10-school week period can span different terms, school years or education settings.

Sanctions may include issuing each parent (for each child) with a Penalty Notice for £160, reduced to £80 if paid within 21 days (for the first offence). A second Penalty Notice issued within a three-year period will result in a fine of £160 per parent, per child. If a third offence is committed the matter may be referred to the local authority for consideration of prosecution via the Magistrates Court. If prosecution is instigated for irregular school attendance, each parent/carer may receive a fine of up to £2500 and/or up to 3 months in prison. If a parent/carer is found guilty in court, they will receive a criminal conviction.

See Annex B for the Hertfordshire Code of Conduct.

There is no entitlement in law for pupils to take time off during the term to go on holiday or other absence for the purpose of leisure or recreation, or to take part in protest activity in school hours. In addition, the Supreme Court has ruled that the definition of regular school attendance is “in accordance with the rules prescribed by the school.”

The School Attendance (Pupil Registration) (England) Regulations 2024 set out the statutory requirements for schools. All references to family holidays and extended leave have been removed. **The amendments specify that headteachers may not grant any leave of absence during term time unless there are “exceptional circumstances” and they do not have any discretion to authorise up to ten days of absence each academic year.**

It is a rule of this school that a leave of absence shall not be granted in term time unless there are reasons considered to be exceptional by the headteacher, irrespective of the child’s overall attendance. Only the headteacher or his/her designate (not the local authority) may authorise such a request and all applications for a leave of absence must be made in writing, in advance, on the prescribed form provided by the school. The school will usually consider that the parent who has made the application is therefore allowing the leave of absence, and that all parents who are on the holiday are allowing the leave. Where a parent removes a child after their application for leave was refused or where no application was made to the school, the absence will be recorded as unauthorised. It is likely that penalty notices will be requested, in line with the National Framework and Hertfordshire Code of Conduct, in respect of each parent believed to have allowed the absence.

At Summerswood Primary School ‘exceptional circumstances’ will be interpreted as:

The fundamental principles for defining ‘exceptional’ are events that are “rare, significant, unavoidable and short”. By ‘unavoidable’ we mean an event that could not reasonably be scheduled at another time, outside of school term time, regardless of who has planned or paid for the holiday or absence (including grandparents or other family or friends).

The headteacher/school may discuss the leave of absence request with other education settings and/or the Local Authority to determine any exceptional circumstances.

If leave of absence is authorised, the school will not provide work for children to do during their absence. Parent/Carers are however advised to read with their children and encourage them to write a diary while they are away.

If you do need to apply for a planned absence during Term time, please complete: Application for term time leave See Annex E), which can be found on our website or requested from the school office. Once this is completed, please return this to

attendance@summerswood.herts.sch.uk and we reply with a decision regarding how the absence will be marked, as soon as possible.

Please note that planned term time leave is very rarely authorised and we will ask for supporting evidence for the exceptional circumstances that you present. Term time breaks can cause significant gaps in a pupils learning which can be extremely difficult for them to overcome. We implore you to take family breaks outside of term time.

Deletion from Roll

For any pupil leaving *Summerswood Primary School*, other than at the end of year 6 parents/carers are required to complete a 'Pupils moving from school' form (please see Annex F) which can be obtained from the school office. This provides school with the following information: Child's name, class, Parent's name, Parent's email address, parent's telephone number, current address, date of leaving, new home address, name of new school, address of new school. This information is essential to ensure that we know the whereabouts and may appropriately safeguard all our pupils, even those who leave us.

It is crucial that parent/carers keep school updated with current addresses and contact details for the pupil and key family members, in case of emergency.

Under Pupil Regulations 2006, all schools are **legally required** to notify their Local Authority of **every new entry** to the admission register **within five days** of the pupil being enrolled. In addition to this, **every deletion** from the school register must also be notified to the Local Authority, as soon as the ground for deletion has been met in relation to that pupil, and in any event no later than the time at which the pupil's name is deleted from the register. This duty does not apply when a pupil's name is removed from the admission register at a standard transition point – when the pupil has completed the final year of education normally provided by that school.

Absence data

We use data to monitor, identify and support individual pupils or groups of pupils when their attendance needs to improve, and schools are required to submit pupil attendance data to the Department for Education on a daily basis Education (Information about Individual Pupils) (England) (Amendment) Regulations 2024. Persistently and severely absent pupils are tracked and monitored carefully. We also combine this with academic tracking, as increased absence affects attainment.

We share information and work collaboratively with other schools in the area, local authorities, and other partners, when absence is at risk of becoming persistent or severe.

REWARDS FOR GOOD ATTENDANCE

- 98% attendance or more at the end of every full term, pupils receive a certificate
- Individual efforts and improvements are recognised regularly by the attendance champion, class teacher or a member of SLT
- When a class achieves 100% attendance, in a week they may attend school in non uniform on the following Monday
 - 100% attendance for the whole year- pupils receive a trophy.

Attendance starts to become a cause for concern- contact is made with parents via call letter or email to advise that attendance is below the government expected minimum. If there has been any unauthorised absence, we reiterate the FPN process and also the process for notifying us of legitimate absence



96%-93%

School to have regular conversations with and send regular reminders to families- which will be personalised depending on the type of absences that have been marked



Under 93%

Attendance is now a cause for concern. Depending on the nature of the absence, a further conversation is had or an in person meeting is arranged either via phone or email with the Attendance officer and the Head Teacher / Class Teacher

Support offered could include:

Referral to relevant group/ agency

Phone call at the beginning of the day

Social stories and/ or personalised rewards

90% or under

When attendance has dropped to 90% or below, a meeting will be held where a warning letter will be issued and a 6 week warning period will begin. Attendance will be meticulously tracked.

After 6 weeks, a review meeting will be held

If attendance doesn't improve and 1 or more sessions have been missed then the statutory attendance letter will be given.

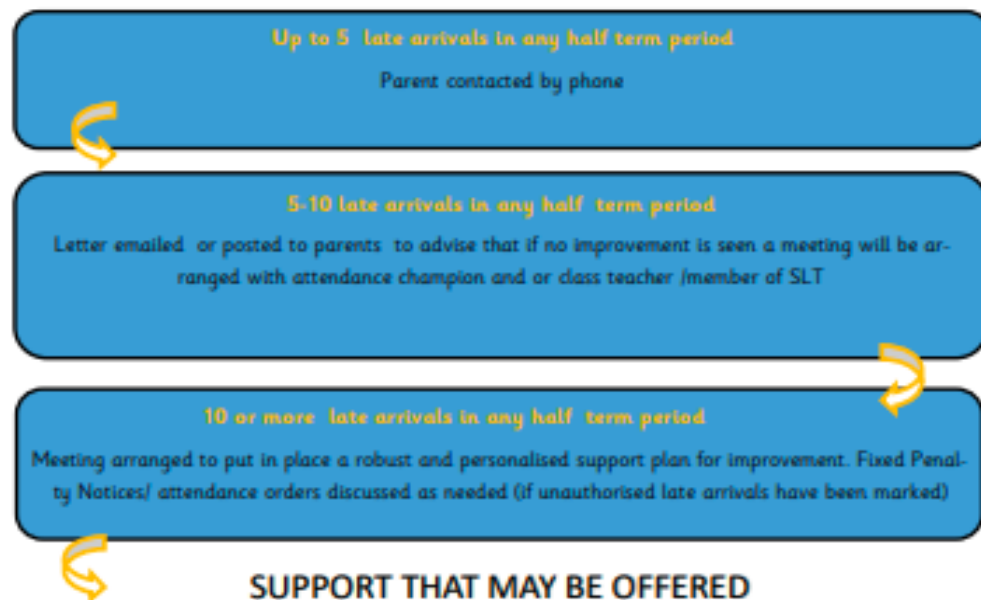
If attendance has improved, this will be celebrated and any further support required will be monitored closely

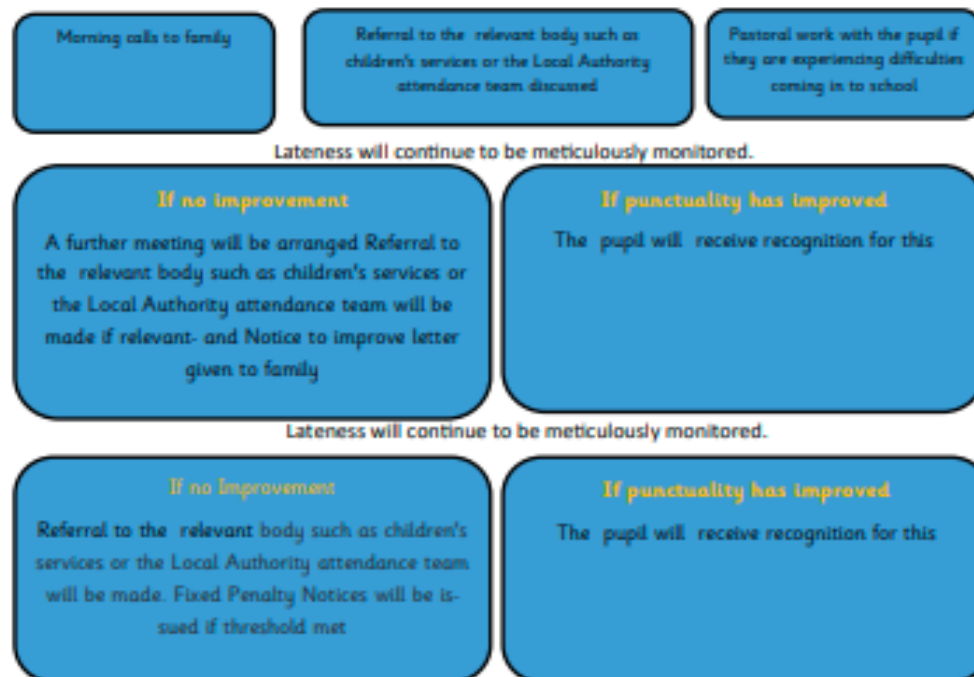
If attendance has not improved, a penalty notice will be issued and/or a referral will be made to the relevant body such as childrens services or the Local Authority attendance team.

Application for Leave of Absence from School during term time.

Dear Parent/Carer,

All schools **by law** must follow the Department for Education's statutory guidance relating to school attendance. They must use the appropriate national attendance or absence code, and follow the criteria set out within the guidance. The statutory guidance states:

- A leave of absence **must not be granted unless there are exceptional circumstances and must be requested in advance.**
- A leave of absence must be requested **in advance** by a parent who the pupil normally lives with
- Schools must judge **each application individually**, considering the specific facts and circumstances and relevant background context behind each request.
- Where a leave of absence is granted, **the school will determine the number of days a pupil can be absent from school.**
- **A need or desire for a holiday or other absence for the purpose of leisure and recreation would not constitute an exceptional circumstance.**
- A school **cannot** grant a leave of absence retrospectively. If the parent did not apply in advance, the leave of absence should not be granted.
- Where this guidance refers to a parent, the school and/or local authority will need to decide which adult(s) is most appropriate. Generally, parents include:
 - All natural parents, whether they are married or not.
 - All those who have parental responsibility.
 - Those who have day to day responsibility for the child.

Please note all schools are expected to regularly inform parents about their child's attendance and absence.

Taking your child out of school during term time could be detrimental to their educational progress. If the absence is not authorised and the leave is taken, schools may refer to the Local Authority for legal action. Please find attached information regarding Helping Parents understand Penalty Notice Fines for School Attendance.

School Expectations

- Children must attend school **on time, every day.**
- Only the **Head Teacher (or Acting Heads)** can authorise absences.

Reporting Absence

Parents must:

- Contact school **before 9:15am on the first day** of absence
- Update the school **every day of absence**

School will:

- Contact you if no reason is given
- Follow safeguarding procedures if unable to reach you
- Contact you for further information if the reason given for absence is unclear or does not meet the requirements for authorised absence

Authorised Absence (acceptable reasons):

- Illness (e.g. temperature over 38c, vomiting or diarrhoea, infectious illness)
 - Medical appointments (with evidence)
- Please note that we ask that you make routine appointments such as dental check ups and eye tests outside of school hours. We can usually only authorise half a day's absence for medical appointments unless further evidence supporting a full day's absence is received.
- Family bereavement

Unauthorised Absence (not acceptable):

- Holidays during term time (unless exceptional circumstances)
- Keeping children off for minor illness (e.g. mild cold)
- Shopping, birthdays, day trips
- Unexplained absences
- Arriving very late (after 9:20am)



Punctuality

- School starts:
- o Gates open: **8:40am**
- o Registration: **8:50am**
- o After **9:20am = unauthorised absence** (which will contribute to the threshold at which Fixed Penalty Notices must be considered).

Legal Responsibilities & Consequences

- 10 unauthorised sessions (5 days) in 10 weeks may lead to a **Penalty Notice**.
- Fixed Penalty rates for a first offence: £80 (if paid early) or £160 per parent, per child

Continued absence may lead to court action and further Fixed Penalty Notices being issued.

Term-Time Leave

- **As per current legal guidance– term time absence is not allowed** unless there are *exceptional circumstances*.
- Must be requested in writing in advance.
- Term time holidays are rarely approved

Attendance Monitoring & Support

- School tracks attendance closely.
- If attendance drops below **95%**, parents will be contacted.
- At **90% or below**, a child is classed as a **persistently absentee**.
- Support may include:
 - Meetings with staff
 - Attendance plans
 - Help from external Services
